32. Planning:

Application Number: CA/21/01657

Location: 'Land at The Hill' Littlebourne, Kent

Proposal: Outline planning application for up to 115 residential (including affordable housing), introduction of structural planting and landscaping, informal public open space and children's play area and surface water flood mitigation and attenuation. All matters reserved except for access.

The planning application was discussed in detail, with comments welcome from the members of the public present.

Outcome: It was unanimously agreed that the clerk compile a response on behalf of the Parish Council <u>OBJECTING</u> to planning application CA/21/01657. <u>See the attached Appendix A</u>- a copy of the agreed comments in the letter submitted to Canterbury City Council.

33. Village Hall Refurbishment.

The VHMC have been awaiting progress from Nathan- who has been liasing with them regarding the refurbishment. The clerk asked for assistance from KALC to ensure the correct procedure is being followed and presented information from the legal team at KALC who advise the following:

"I would expect them to approach you with estimates and a full proposal to which you will then apply your criteria, making sure the Parish Council are the last resort and they can demonstrate they have tried elsewhere first for funding and then look at what the Parish Council are prepared to support. In addition, I would expect the VH committee to seek input and support from their supporting body ACRK Action with Communities in Rural Kent (Rural Kent)- Clive"

KALC also sent over documentation which will help support the process. This states that if the work is over £25,000 it must go out to tender on contracts finder/find a tender website. Clerk to forward this information on to VHMC.

It was agreed that Viridor grants should be looked into- to see if the project would be eligible. Clerk to work with VHMC so the Parish Council and VHMC can collaborate on the project.
