**7.1** Email received from resident asking if there's any mileage in the Parish Council writing to Kent Highways regarding the blocked drain just above Yew Tree Cottage? It's now completely blocked so that water just runs down the hill which is very nasty in icy weather.

**7.2** The following was received from resident regarding Patrixbourne roundabout: I would like to bring to your attention an area of road that desperately needs to be improved for safety. Please find attached photos of this which demonstrate the danger for my children - particularly my daughter who uses her electric wheelchair to meet her mobility needs. The roundabout at Patrixbourne is metres from our home and I do not believe it will require a great deal to improve it. My daughter is not able to move on to the grass when the traffic is coming towards us. The road is wide enough to have a pedestrian red tarmacked path for pedestrians, wheelchair users and push chairs which would benefit our community. The change of road colour will slow cars down, as in my experience they come too fast towards the roundabout in all directions. I would be grateful if this could be reviewed as my daughter has every right to enjoy the countryside around us. Any improvements made will be in line with:

Section 149 - Public Sector Equality Duty of the UK Equality Act.

Article 5 (Equality and non-discrimination) and Article 9 (Accessibility) of the Convention on the Rights of Persons with Disabilities, which the UK is a signatory to and legally obliged to implement.

# 11. Village Hall Management Committee

G. Duplock gave the following update from the VHMC:

Things are going well, lots of enquiries and bookings are coming in. Currently on track for the projection of the VHMC's 4 year plan.

G. Duplock left the meeting for the remainder of this agenda item due to his declared interest.

The following information was circulated in a an email to councillors prior to the meeting: Valuation 7 is due (£15,878.24 inclusive of VAT)

The VHMC have circa £6,000 in available funds. £16,000 has been applied for via ACRE's Rural Community Buildings Loan to fund upcoming invoices regarding the refurbishment. There has been a slight delay in this application due to the local branch of ACRE being merged to a more central branch.

The VHMC are therefore requesting the Parish Council to assist with a further grant for the sum of £9,000 to cover the shortfall while the VHMC await the loan.

The parish council discussed this at length. It was noted that the parish council's contribution has has already been significantly increased to cover the overspend on the refurbishment.

**Resolved** It was proposed by C. Ash and unanimously agreed that the parish council do not award the requested grant and that the parish council would urge the VHMC to chase the loan application. Clerk to meet with G. Duplock to seek clarification on the financial situation of the VHMC.

G. Duplock returned to the meeting.

# 12. Recreation Ground Management Committee

M. Evans gave the following update as chair of the RGMC:

The RGMC wish to note their thanks for the recently awarded contribution of £2,000 from the parish council. Things are progressing well and the RGMC have recruited new trustees, and steps are being taken to re-allocate the responsibilities associated with the running of the recreation ground/pavilion. The decision has been made to remain as an independent organisation/charity.

# 13. The Coronation of King Charles

At present the parish council have no plans for an event to celebrate. It was suggested that perhaps a tree could be planted at the recreation ground to commemorate the Coronation.
